- Open public swim takes place simultaneously for pool parties
- Children 5 & under swim for free
- Children 7 and under & children under 48 inches tall must be accompanied by an adult in the pool - no more than 2 children per adult
- No tubing – only life preservers or certified flotation devices
- **Pool swim rates - (to be paid on day of event):**  
  - \$3 – Without Pool Residency Card
  - \$2 – Adult with Pool Residency Card
  - \$1 – Seniors/Children with Pool Residency Card
- No Food or Drinks Supplied – you can bring or have delivered
